Dear City Council,

Support the initiatives towards improving the housing situation in Saskatoon using the Housing Accelerator Fund:

I recently learned that the City is proposing changes to zoning bylaws that would allow:

up to four units of housing on any 50ft residential property city-wide up to Four-storey housing in areas close to Transit corridors across the city up to Six-storey housing on Transit Corridors and near transit stations

I understand that these changes are being proposed in order to:

speed up the creation of more housing units

make it possible to create more housing in existing neighbourhoods

make sure Saskatoon qualifies for the Federal Housing Accelerator Fund that the City will use to help get more affordable housing units built

I support the proposed changes and ask that City Council vote in favour of them on June 27. These changes will help combat the housing crisis in our community and make it easier for families and neighbours to find better, more affordable housing.

Combatting the housing crisis is important to me because:

- as a young professional, it is getting harder for me to sustain in the city after my degree. In the meantime, Saskatoon is growing and has a lot of potentials, which requires young professionals to stay, and the HAF initiatives will help ease their cost of living and permanent settlement in the city. More people able to settle means more talents stay to bring wealth to the city through property taxes, business opportunities, jobs and external attractions.
- our unhoused population is increasing. Many of our brothers and sisters have suffered on the streets and passed away due to extreme weather. The provision of housing and affordable housing will help address public health, living quality, and economic development for the city.
- public transit needs good land use to function well. The HAF initiatives will ensure a good ridership for public transit, which helps ease the cost of operation via increased fare revenue, and help transit functions.
