BYLAW NO. 10024 The Zoning Amendment Bylaw, 2024 (No. 20)

The Council of The City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Zoning Amendment Bylaw, 2024 (No. 20)*.

Purpose

- 2. The purpose of this Bylaw is to amend the Zoning Bylaw to:
 - (1) rezone the lands described in the Bylaw to apply Corridor land uses from:
 - (a) a DCD2 District to a CS1 District;
 - (b) an M2 District to a CS1 District; and




