### **BYLAW NO. 10026**

## The Zoning Amendment Bylaw, 2024 (No. 22)

The Council of the City of Saskatoon enacts:

#### Short Title

1. This Bylaw may be cited as *The Zoning Amendment Bylaw, 2024 (No. 22)*.

#### Purpose

2. The purpose of this Bylaw is to amend the Zoning Bylaw to rezone the lands described in the Bylaw from a IL1 District to a CM1 District.
