## Zoning Bylaw Comprehensive Review Project

The Comprehensive Review of the Zoning Bylaw Project (Project) was undertaken to align Bylaw 8770, Zoning Bylaw, 2009 (Zoning Bylaw) with identified strategic priorities, current trends, changes to provincial legislation and to make minor amendments. This is the final report, and the proposed new Zoning Bylaw is the culmination of this Project.

The list of potential amendments identified was extensive and included several topics. The project was divided into smaller portions and amendment packages were prepared.
