Proposed Closure of Right-of-Way – Portion of Wess Road – Rosewood Neighbourhood (Arbutus Properties)

ISSUE

Administration requests approval to close a portion of Wess Road between the intersection of Wess Road and Zimmerman Road and 225 Market Drive. This portion of Wess Road is not currently developed as roadway and is not open to traffic. This portion of right-of-way will be transferred to Arbutus Properties and combined with adjacent properties currently owned by Arbutus Properties for future development.

RECOMMENDATION

- 1. That City Council consider Bylaw No. 10039 The Street Closing Bylaw, 2024 (No. 4);
- That after closure the former right-of-way be transferred to Arbutus Properties;
- 3. That all costs associated with closure be paid by the applicant, including Solicitor's fees and disbursements.

BACKGROUND

Arbutus Properties approached the City of Saskatoon about closing and purchasing a portion of the Wess Road undeveloped right-of-way and consolidating the portion with existing parcels in the Rosewood neighbourhood. The portion of undeveloped right-of-way is not needed for current or future transportation purposes.

The provincial Ministry of Highways requires compensation for this portion. The Ministry of Highways and Arbutus Properties have come to a compensation agreement for this portion of public right-of-way.

DISCUSSION/ANALYSIS

The following steps, in chronological order, have been completed as detailed in Table 1.

To complete this transaction, the Administration requires that City Council approve Bylaw No. 10039 - The Street Closing Bylaw, 2024 (No. 4) (Appendix 1).

A dead-end will be created and legal access to two parcels will be eliminated, however the owner of these two parcels (Edgar Properties V Ltd.) has agreed to purchase a portion of Wess Road from the Ministry of Highways to consolidate their properties with this right-of-way. That proposed closure report is also being discussed at the same meeting as this closure. With approval of both of these two closures/Bylaws, there will be no legal access concerns.

Utility agencies have been contacted with respect to the closure. SaskEnergy, SaskTel SaskPower and Shaw have easement requirements.

Communication activities are included with the requirement for Public Notice. No other communication activities are required.

FINANCIAL IMPLICATIONS

There are no financial implications to the City of Saskatoon as a result of this proposed bylaw.

OTHER IMPLICATIONS

Public Notice is required for consideration of this matter, pursuant to Section 3 (subsection b) of Policy C01-021, The Public Notice Policy. The following notice was provided:
