I am **OPPOSED** to the recommendation of the Standing Policy Committee on Finance; "that the City Solicitor be requested to prepare the appropriate bylaw amendments to the Landfill Replacement Reserve within Bylaw No. 6744, The Capital Reserve Bylaw, 1993 as outlined in this report".

My opposition is based on the following:

- 1. The Landfill Replacement Reserve purpose is clear, "to finance the cost of replacing the City's landfill." This reserve was established in 1991 and, at the end of this year, it will be in a negative balance. The CFO's comment at the SCP-Finance meeting speaks to interpretation of this reserve:
 - "The Administration's interpretation and usage of the reserve has been for projects that optimize or extend the life of the existing landfill. So, I do know there is some misinterpretation of this is strictly to close the existing landfill and build another one twenty miles away or wherever it may be constructed but Administration's intent is to have the existing lifespan of the current landfill extend as long as possible and we've been using this funding for optimization projects and new cell expansion and those types of projects as well."
- 2. There is no indication of the current lifespan of the landfill. The General Manager of Utilities and Environment commented at the SPC-Finance meeting: "Our intent is to not have to replace. Ultimately, we don't wanna have to replace the landfill" and "We will be undertaking an integrated landfill management plan in 2025 and that's going to refresh previous analysis and information."
- 3. There is no indication of the current cost of decommissioning the current landfill and establishing a new landfill (has a new landfill location even been determined yet?). The General Manager of Utilities and Environment commented at the SPC-Finance meeting: "Actually, if I could maybe add. The \$100 million was just the replacement cost but the decommissioning and closure cost of the existing landfill would be an additional \$50-75 million on top of that. So, at that time, we were almost at \$200 million total."
- 4. If the Bylaw is amended to replace the base provision of "\$410,000" with "funded annually from an authorized provision in the City's Operating Budget", does that mean that an authorized provision could be less than that, or even \$0?
- 5. If the funding of this reserve also relies on tonnage, and the tonnage is decreasing (based on numbers provided by the CFO below), what is the plan to fund this reserve to finance eventual replacement of the landfill?
