## Comments:

My name is Derek Cameron, submitting comments on behalf of Strong Towns YXE.

As a frequent bus rider and advocate of the public transit system, I want to urge council to follow administration's suggestion Option 1 – Purchase Fixed Route Diesel Buses and Access Transit Gas Buses.

Option 1 will help get more buses on the road in a quick and efficient manner compared to the other options that result in either many fewer buses purchased, or a dramatic price increase. Overcrowding and reduced frequency threatens the strong growth in ridership seen in recent years. Having more buses to meet the needs of riders, in an efficient manner, must be at the heart of any purchasing decision. Further, getting more people out of cars, and onto the transit system will ultimately yield better carbon reductions than a focus on municipal fleet decarbonization.

As Battery electric technology matures, it may be prudent to purchase electric replacements, especially if Federal support is given. At this time however, the most important step council can take is to support more buses and better service for existing and future transit riders. The BRT system can only succeed if there are enough buses to service all riders.
