BYLAW NO. 10054

The Traffic Amendment Bylaw, 2025

The Council of the City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Traffic Amendment Bylaw, 2025.*

Purpose

- 2. The purpose of this Bylaw is to amend *The Traffic Bylaw* to:
 - (a) modify the boundary of the Fringe Festival parking area; and
 - (b) grant discretion to the City to provide additional parking permits in the Fringe Festival and the Exhibition Week parking areas based on demonstrated need and parking spot availability.

3. The Traffic Bylaw is amended in the manner set forth in this Bylaw.

Section 56.1 Amended

- 4. (1) Subsection 56.1(1) is amended by:
 - (a) adding "Subject to subsection (3)," before "Two Exhibition Week"; and
 - (b) striking out "Two" before "Exhibition Week" and substituting "two".
 - (2) Subsection 56.1(2) is repealed and the following substituted:
 - "(2) Parking permits issued pursuant to subsection (1) are valid only in the areas shown in Schedule No. 13 or Schedule No. 14 during Exhibition Week or the Fringe Festival, respectively and only during the hours specified by the signs posted in the area."
 - (3) The following subsection is added after subsection 56.1(2):

- "(3) The City may, at its sole discretion, issue additional parking permits upon receiving a written request from the owner or occupant of a unit after considering the following factors:
 - (a) whether the owner or occupant of the unit making the request has demonstrated a reasonable need for additional parking permits;
 - (b) whether the parking demand in the area accommodates the issuance of additional parking permits;
 - (c) any other factor that, in the opinion of the City, supports the issuance of additional parking permits.".

Schedule No. 14 Amended

5. Schedule No. 14, Fringe Festival Parking Permit is repealed and the schedule marked as Schedule "A" to this Bylaw is substituted.



- Broadway Avenue: 600, 700, & 800 Blocks
- Dufferin Avenue: 500, 600, 700, & 800 Blocks
- Eastlake Avenue: 500, 600, 700, & 800 Blocks
 Lansdowne Avenue: 400, 500, 600, 700, & 800 Blocks
- Main Street: 400 (north side), 500 (north side), 600 (north side), & 700 (north side) Blocks
- Saskatchewan Crescent East: 400, 500, & 600 Blocks
- Temperance Street: 600 Block University Drive: 600 Block
- Victoria Avenue: 700 (east side), & 800 (east side) Blocks
- Albert Avenue: 400 (west side), 500 (west side), 600 (west side), 700 (west side), & 800 (west side) Blocks
- 10th Street E: 400, 500, 600, 700, & 800 Blocks
- 11th Street E: 400, 500, 600, 700, & 800 Blocks
- 12th Street E: 400, 500, 600, 700, & 800 Blocks
- 13th Street E: between Saskatchewan Crescent East and Albert Avenue
- 14th Street E: between Saskatchewan Crescent East and Albert Avenue
