## Comments:

At the budget deliberations in December (timestamp 5:21:15), the Fire Community Support program was discussed for 19 minutes. We learned:

- an update on the program would be provided at the one year mark (fall of 2025)
- the annual Transit report will include stats on negative incidents by type (first half of 2025)
- data is reviewed on an ongoing basis internally and meetings are held regularly
- data is used to target where the FCS resources are deployed (BIDs or Transit)

- over the last year, there has been an increase in social disorder type incidents on Transit across all different categories

- a decrease in assaults to operators largely due to barriers that were installed and increased presence by supervisors

- an increase in acts of aggression (intent to do harm but no physical harm is not done)
- passenger on passenger incidents have been increasing

- there were 42 interactions with the FCS staff on Transit to support drivers and passengers, as at the time of the budget meeting

What we did not learn:

- where did the 42 interactions take place
- what transit routes have been targeted by the FCS program
- has the presence of FCS officers increased safety by deterring negative incidents
- has the presence of FCS officers increased the perception of safety by riders

- what specific data or trend would trigger an early report to Council to adjust the program's effectiveness and resources

In closing, the former Community Support Program had comprehensive reporting done quarterly and reported publicly at the Street Activity Subcommittee meetings. Here is the final report that was presented at the March 2024 meeting (<u>https://pub-saskatoon.escribemeetings.com/filestream.ashx?DocumentId=208727</u>). The detail and corresponding stories that were shared on a regular basis were critical to making decisions regarding resources and budgeting. The lack of public reporting on the Fire Community Support program is a missed opportunity, especially in this early stage, considering the history of reporting under the previous program.
