While I am thrilled to see affordable housing being proposed for my neighbourhood and excited to see the parcel of land at 2401 Broadway Ave., be used for good, I am concerned by the "N/A" listed in the Support Services section of the small notice on this proposal.

Does this mean - as it appears - this there is no plan on the City or the Developer's behalf to offer any kind of support services for the future residents of this proposed building?

Could more details on this building and its end uses be made available to the surrounding community? I am concerned that without any plans for support this building risks not fulfilling its purpose.

What assurances do the people in Ward 7 and Saskatoon have this this building will be kept as 100% affordable housing? I see in the report the that this condition is only required of rental properties and only guaranteed affordable rental for 20 years. Why so short? Given Saskatchewan has no rent control, is Council in support of tenants be booted out as soon as the 20 year window has been passed? Can the City take steps to keep this affordable beyond the 20 years? Is there a rent to ownership option available for potential future tenants? The "Brochure" on 2401 Broadway does not address my questions above.
