


# 2024 Annual Traffic Report



#### Introduction

The Saskatoon Police Service Traffic Unit is committed to ensuring the safety of all Saskatoon residents and visitors to our city who share our roads, sidewalks, and bike trails. In addition to enforcement activity, the Traffic Unit also encompasses collision and hit and run investigations.

Our enforcement team uses selective techniques, as well as targeted traffic projects, and a variety of educational campaigns in order to maximize compliance with provincial and municipal driving legislation. Police officers are highly trained in the use of Radar and Laser speed detection technology, and are equipped with the latest tools of the trade to effectively perform their duties. They use a variety of vehicles, including motorcycles to patrol our streets.

Saskatoon Police Traffic officers regularly team up with outside agencies such as the Saskatchewan Highway Transport Patrol, Vehicle Equipment Compliance inspectors, CTSS, University of Saskatchewan Protective Services, RCMP and other municipal police services for the purpose of safety campaigns. STEP (Selective Traffic Enforcement Program), Multi Agency Seat Belt Team (MAST), Operation Overdrive Sobriety Checkpoints and Child Seat Safety Clinics are but a few examples of this collaborative effort geared towards the creation of a safe roadway network.

The Traffic Unit consists of 20 enforcement members including 2 sergeants, 2 Hit and Run investigators, 2 Collision Analysts, 1 Red Light Camera member, and 1 Automated Speed Enforcement member.

## **Traffic Ticket Categories**

• The Traffic Unit members gave out close to three-quarters of all traffic tickets issued by SPS in 2024.

- Top tickets for VER include Illegal Sunscreens, Damaged Windshield and Inadequate Muffler, Fender or Mud Flaps.
- 41 Drivers were caught exceeding the speed limit by over 50 km/hr.
- 140 Drivers were caught exceeding the speed limit by 35-50km/hr.
- 771 Drivers were found to be driving while disqualified or suspended.
- 1128 Tickets issued regarding unregistered vehicles.
- 766 Seatbelt related tickets were issued.

When serious collisions occur, the SPS Traffic Unit Collision Analysists reconstruct the scene to investigate, analyze and draw conclusions regarding the causes and events of a collision. The Collision Analyst Unit is made up of a group of highly trained officers who are responsible for investigating serious injury and fatal collisions. These officers receive ongoing first-rate training in various disciplines including physics, math, photography, forensic mapping and 3-D animation. In addition to this training, some members of the team have received specialized training in the investigation of collisions involving motorcycles, pedestrians and commercial vehicles.

In response to the increase in collisions in 2023 and 2024, seven Traffic Unit members have completed training and are now Certified Level III Collision Investigators. This will relieve some of the file burden on our regular Collision Analyst members, and assist with completing thorough investigations.

## **Operational Focus**

The focus regarding enforcement will be to emphasize those offences known to pose the greatest risk to public safety, known as the "Big Four":

- 1. Distracted Driving (cellphone use)
- 2. Aggressive Driving (speed & hazardous driving behaviors)
- 3. Passenger Restraints (use of seatbelts)
- 4. Impaired Driving

Distracted Driving violations were down considerably in 2024. This is likely the result of SGI's increased media campaign to encourage drivers to stay off their mobile devices while driving. The public awareness campaigns appear to have also aided in the decrease of seatbelt and impaired driving violations.

## **Traffic Unit Staffing and Initiatives**

- 2 Hit & Run Constables
- 1 Automated Speed Enforcement Constable

  - The Traffic Unit's enforcement efforts were hampered in 2024, due to the reassignment of seven members during the spring and summer months for Project Magpie. One of the Unit's regular sergeants was included in the re-assignment. This meant that an enforcement constable was required to fill in as an acting sergeant for a number of months, thus restricting our enforcement efforts further.
  - Our members coordinated and assisted with over 60 operational plans during the year. These events were related to marches, parades, rallies, and protests throughout the city.

Traffic Unit members participated in the following training initiatives in 2024:

- Level II Collision Investigation, Level III Collision Investigation, Impaired Driving Investigation, Senior Constable Development, Light Vehicle Inspection, Light Trailer Inspection, Seatbelt Installation Clinic, Approved Screening Device, Standard Field Sobriety, Oral Fluid, and Drug Recognition Expert courses.
- Our members conducted presentations throughout the year for the SGI PARTY (Preventing Alcohol and Risk-Related Trauma in Youth) program, Cultural COPS Cadet program, Impaired Driving lectures, and the Lunch & Learn Patrol re-orientation program.

## **Traffic Stop Profile**

In Sept 2024, an officer with the SPS Traffic Unit attempted to pull over a motorcycle that driving at a speed twice the legal limit near the intersection of Idylwyld Drive North and 32nd Street West. Officers were able to observe the driver was running red lights while on his cell phone. When attempting to pull him over he remounted the cell phone and took off at a high rate of speed. Officers quickly backed off due to public safety concerns, but other officers in the area were able to locate the driver near 22nd Street West and Witney Avenue. Officers were able to slow the driver to a near stop but the suspect intentionally rammed a police motorcycle. This caused both motorcycles to fall to the ground.

The Traffic Unit officer who was on the motorcycle, was not only uninjured but he also was able to safely remove the suspect from his scratched-up bike, and arrest him. The driver, an 18-year-old man, has been charged with Dangerous Driving, Evading Police and Mischief Over \$5000.

Incidents like this highlight the importance for traffic safety rules. While this incident didn't appear to injure anyone in the public, the driving displayed could have easily resulted in death or injuries for any number of pedestrians or other drivers. The SPS Traffic Unit is dedicated to applying the law consistently to reduce injury and even death.
