

BYLAW NO. 10059

The Official Community Plan Amendment Bylaw, 2025

The Council of The City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Official Community Plan Amendment Bylaw, 2025*.

Purpose

2. The purpose of this Bylaw is to amend the Land Use Map to change the land use designation of the land described in this Bylaw from:
 - (1) Direct Control District to Corridor Mixed Use;
 - (2) Direct Control District to Station Mixed Use;
 - (3) Direct Control District to Corridor Residential; and
 - (4) Corridor Main Street to Corridor Residential.

3. The Official Community Plan, which is annexed as Schedule “A” to Bylaw No. 9700, and forms part of *The Official Community Plan Bylaw*, is amended in the manner set forth in this Bylaw.






OFFICIAL COMMUNITY PLAN AMENDMENT
