**Comments:**

Dear Councilors,

I am writing to express concern regarding the recommendation in the “Coyote and Feeding of Wildlife Update Approval Report” that the City “engage a contractor to provide the more advanced components of a coyote management plan including aversion conditioning and euthanasia.”

My first concern is with the scant research supporting the report’s recommendation about hiring a contractor. First, the report only presents a jurisdictional scan rather than research-based best management practices for urban coyotes – these two are not necessarily the same! Second and more concerning, there is a lack of expert consultation. For example, Dr. Ryan Brooks (U of S), Dr. Douglas Clark (an expert in human-wildlife interactions at the U of S), and the Saskatoon Urban Wildlife Information Network would be excellent sources of local insight, yet they were not consulted. Local experts could provide suggestions tailored to Saskatoon, which might avoid the brute force approach of giving a contractor carte blanche to do anything up to and including killing coyotes. I also suspect that suggestions from local experts would cost the city far less than a contractor– I was astounded to see in Appendix 3 that coyote contractors cost \$260,000-280,000 per year in Calgary!

My second concern is the lack of concrete data demonstrating a need for actions as extreme as killing coyotes. The report states that in 2024 there were only five “conflicts” with coyotes, of which four involved no coyote-human contact. While the one incident in which there was contact with the coyote is certainly unfortunate, I believe that engaging a contractor and giving them free reign to use lethal force is an overreaction. Given that 1 or even 5 “incidents” is a tiny fraction of the ~210 (estimating from the bar graph) coyote calls received by the City, it seems that current responses of public education, posting signs, etc. do seem to largely be preventing bad outcomes. Finally, I firmly believe that it is far more important for the City to ramp up awareness campaigns and public education than engage a contractor. We in Saskatoon, we are fortunate to have many greenspaces that provide habitat wildlife, including coyotes. We should recognize that existing near greenspace requires some responsibility on our part and acknowledge that human behaviour is often the root cause of coyote-human interactions. If we focus on awareness of our own responsibilities, escalating to the use of lethal force will be unnecessary.

In closing, I ask Council to reject the proposal to hire a contractor to haze and kill coyotes. I will further remind Council that we are in the midst of a globally-recognized biodiversity crisis, and that coyotes, like all species, are important components of the ecosystems that sustain us.
