8.2.1 22nd Street and Confederation Drive Intersection Improvements – March 2025 Update

Hello City Council members,

I only frequent this area once or twice a month, so I am not aware of the current traffic concerns or the implications of the proposed improvements.

What I am aware of is a BRT station that is planned for the south-east corner of Diefenbaker Drive and 22nd Street, between Diefenbaker Drive and the proposed Fairlight Crescent turn out access. This 36m infrastructure is not indicated on the provided drawings for the recommended option and, because this location is not currently in this year’s construction queue, I do not know the details for the construction (is the porkchop island at Diefenbaker/22nd St being removed, is the bus stopping in a lane of traffic or will there be a turnout). Therefore, I have some questions:

- Why is this BRT stop not indicated as a future development on the functional design, since it will be taking place within the next couple of years?
- Has the multi-use pathway on the functional design considered access to the BRT station?
- As no bus stop has ever been on 22nd Street west of Confederation Drive before, does this functional design consider Transit movement for any connecting transit network?
- Since this section of 22nd Street is considered an expressway with a posted speed limit of 60 km/h, does this BRT station have any impact on traffic operations or safety?
