Dear Mayor and Members of City Council,

We write in support of our application requesting discretionary use approval to operate a day care centre for up to 20 children at our residence located at 440 Evergreen Boulevard in the Evergreen neighbourhood.

Over the past year, we have worked closely with City Planning staff, consulted with local residents, and participated in a Public Information Meeting to ensure our proposal is responsive to both neighbourhood feedback and municipal guidelines. As residents of Evergreen ourselves, we are committed to providing a high-quality, community-focused child care service that supports working families while maintaining the character and livability of the neighbourhood.

#### **Overview of Proposal**

- **Zoning Compliance**: The property is zoned R1A Low Density Residential District 1A under Bylaw No. 9990. A day care centre is a discretionary use in this zone.
- **Capacity**: We revised our original proposal from 24 children to 20 children to address feedback regarding traffic and neighbourhood scale.
- Operations:
  - Hours: Monday–Friday, 7:00 a.m. to 6:00 p.m.
  - Staff: Managed by us with one additional staff member.
- **Outdoor Play Space**: A fenced backyard offers 142 m<sup>2</sup> of secure outdoor area, exceeding the Zoning Bylaw's minimum requirement of 7 m<sup>2</sup> per child.

# **Community Engagement & Mitigation of Concerns**

• **Traffic & Parking**: We will provide four on-site parking spaces (two for staff, two for dropoff/pick-up). Our corner lot allows safe on-street parking on Zary Road. We will also implement staggered drop-off/pick-up times to avoid congestion.

- **Site Management**: We will ensure regular garbage collection and maintenance, and take responsibility for snow clearing and cleanliness of adjacent sidewalks and curb areas.
- **Neighbourhood Compatibility**: By operating within our home, we offer a warm and family-oriented environment. Our efforts to reduce intensity and respond proactively to community concerns demonstrate our long-term commitment to the neighbourhood.

• **Zoning Bylaw & OCP**: Our application meets all applicable regulations under Zoning Bylaw No. 9990 and supports the City's Official Community Plan goals by enhancing child care accessibility and promoting inclusive, family-friendly neighbourhoods.
