As the Director of Operations of a Riversdale business, I am writing to urgently implore you to address the escalating interrelated crises of addiction, security, and homelessness that are impacting the safety, health, and dignity of countless individuals in our city. This humanitarian emergency not only affects those experiencing homelessness but also strains our public spaces, healthcare and policing systems, and community well-being. We need immediate, coordinated action that includes access to affordable housing (immediate options while the future developments on this are constructed), expanded access to mental health and addiction services, and sustainable support programs. It is imperative that our city and our province prioritize compassionate, effective, and immediate solutions to ensure that no one is left behind and our city is able to recover and flourish. Countless previous conversations on this subject have put blame and responsibility on higher levels of government, but we are begging for support, advocacy, and initiatives from the City to address this as best we can, and for the City to collaborate with us to convince the provincial and federal governments that their assistance is compulsory and urgent.
