Speech from the Throne (2020)

- Expansion of urban parks

Federal Budget (2021)

- Historic investment over 5 years in Canada's natural legacy including \$130 million to create a network of national urban parks

Speech from the Throne (2025)

- Government will protect more of Canada's nature including the creation of new national urban parks
