Re: Bus Rapid Transit (BRT) on Broadway Avenue

The Broadway Business Improvement District is supportive of needed changes to Saskatoon's transit network. These enhancements will contribute to the strength of the downtown and surrounding areas including Broadway. A measurement of success for the BBID and the urban design of the district is accessibility via all modes of transportation. Transit improvements will provide a great opportunity for more people to see the City bus system as a viable means of transportation. The federal funds available for the Bus Rapid Transit will support these much-needed improvements and we need to be able to capitalize on these opportunities.

The BBID supports the BRT on Broadway Avenue with accompanying investment and preservation of the public realm character-defining elements. The Growth Plan and the BRT routing analysis stated Broadway Avenue is a key transit route due to the diversity of land use in employment and population. Analysis of future land use patterns shows the corridor will continue to support transit-oriented development and be a significant generator of transit trips. This speaks to the vitality of the district and the long-term resiliency and endurance of Broadway.

While we support investment in transit and the BRT, the BBID merchants have many outstanding questions and concerns. Dedicated bus lanes have been proposed for the length of the district from 12th Street to 8th Street. Business and property owners in the district require a more fulsome explanation of the disruption proposed through construction in the area including timelines and phasing as well as future traffic patterns. Water main replacement work in 2016 and 2017 had a severe effect on customers accessing businesses on Broadway resulting in hundreds of thousands of dollars in lost revenue. Some businesses chose to relocate, others closed permanently.

Greater communication with open and transparent dialogue is needed in all future construction projects within business districts. Businesses need to be a part of decision making processes. Construction which disrupts business function must be accelerated and phased to reduce upheaval.

From what we have seen presented, there appears to be no direct route from Broadway and Nutana to the University. Many cafes, pubs, retailers and much of the surrounding housing market rely on students and university employees. The downtown is easily accessible by many



forms of transportation already; we seek greater connectivity with the University through mass transit.

While understanding that it early in the design process, many comments and concerns remain unanswered from business owners.

- Can the village atmosphere of our heritage district be maintained?
- Will the pedestrian experience be negatively impacted by the reduced tree canopy, and increased traffic, pollution and noise?
- How will auto traffic be affected with cars blocking the single driving lane by maneuvering to parallel park?
- How will parking be affected both on Broadway and in the residential neighbourhood?
- With a BRT route of Victoria Ave or on the freeway, could a stop on Broadway Ave and 8th Street or alternatively, Broadway Ave and Main Street, lead to the same result of transit users being able to access Broadway without disruption through construction and reconfigured and reduced traffic routes?
- Is the dedicated runninglane mandatory at the outset of the system? Could it be phased in as ridership or traffic increases?

Broadway is a distinctive, vibrant and visually remarkable district that supports built heritage and innovation, balances being a walkable neighbourhood with being a main traffic corridor, and draws many people to our city to visit, live and work. The *je ne sais quoi* of Broadway is perceived by many to be in jeopardy if the dedicated BRT lane is implemented in the district while others believe having Broadway be a part of the very spine of the transit network will benefit the street and the city as a whole. The BBID looks forward to learning more about the answers to many of our merchants outstanding questions and continued engagement as the BRT is implemented in Saskatoon.



At my software development company, I have staff who commute by bike from as far as University Heights, Hampton Village, and Exhibition. I have staff and clients who arrive by bike and on foot, year round. All staff in our office regularly patronize other downtown/Broadway/Riversdale businesses (some daily), and we arrive on foot or via bike.

The BRT and DCN are key pieces of public infrastructure that help build an attractive, dynamic and diverse downtown. These features are also important to employee recruitment and retention.

It is critical to my business that our city remains competitive with our neighbours - Calgary, Edmonton, Vancouver, Winnipeg. These cities compete for high-tech/'creative class' employees who seek not just challenging and high paying jobs, but also the dynamic and diverse lifestyle provided by a vibrant downtown.

My wife is also a downtown business owner, also directly on the bike lane network, and also strongly supports the BRT and DCN plans. We both enjoy the urban revitalization and diversification that we see around these networks in all the cities we visit, and see the potential in Saskatoon as well.



I also wish to point out that the various business lobby groups do not speak for all businesses, nor even for all of their members.

I ask City Council to follow its own previous recommendations, and to support your professional staff in designing and implementing the details of these plans.
