Noise Bylaw Extension Requests to Environment, Utilities & Corporate Services Committee

The Special Event Interdepartmental Committee (Administration) consists of representatives from 12 different divisions including Transportation, Facilities, Parks, Parking Services, Transit, Saskatoon Police Service, Saskatoon Fire Department, Emergency Measures Officers, Environmental & Corporate Initiatives, River Landing, Corporate Risk, and Recreation and Community Development.

Administration has reviewed the following noise bylaw extension requests:

1) PINK Street Party

- a. Event Dates: Saturday June 23rd 9pm – 2am
- b. Location: 24th Street East from Idylwyld Drive to Pacific Avenue (Ward 6)
- c. Event Organizer: Mariel Pochynuk
- d. Recommendations: While this event has occurred in the past, administration has received complaints in 2016 regarding noise level and the extended time period until 2am. In 2017, EUCS committee approved an extension until 12am and received no complaints. Administration recommends approving the 2018 noise bylaw extension request to 12am subject to the noise bylaw extension guidelines (see attached).

2) Lawn Summer Nights

- a. Event Dates: Thursday July 12th 5:30pm-11:00pm
- b. Location: Mayfair Lawn Bowling - 923 Avenue D North (Ward 2)
- c. Event Organizer: Julia Rollack
- d. Recommendations: In 2017, administration received a complaint regarding this private event with extended periods of bass sounds without any breaks. Administration recommends approving the noise bylaw request subject to the noise bylaw extension guidelines (see attached). Administration will also be in contact with the event organizer to ensure these administration conditions are adhered to.

3) Food Truck Wars Street Festival

- a. Event Dates: Friday July 27th 11am-11pm, Saturday July 28th 11am-11pm, Sunday July 29th 11am-7pm
- b. Location: 20th Street West from Ave C to Ave F (Ward 2)
- c. Event Organizer: Rick Mah
- d. Recommendations: This is the first year of this event on civic property and administration has no concerns and recommends approving the noise bylaw request subject to the noise bylaw extension guidelines (see attached).
